

**Student 's Parent/Guardian Agreement  
Participant in the ENS Student's Scholarship Award Program  
For the academic year 2023/2024**

I ..... The undersigned, the student's guardian ....., I agree, undertake, and abide by the terms and conditions of the scholarship contained in this document, its dependencies, and its updates (the Parent's Commitment and Pledge Document ) , as I acknowledge that I have participated in the ENS Student's Scholarship Award Program (the Program), who kindly offered a scholarship For the male/female student under the supervision of Emirates National Schools, according to which the scholarship value is paid to the school of .....in grade /year ....., This is for the academic year 2022-2023 until graduation from school, if he does not violate the terms of the grant or withdraws from it.

**Article 1:  
Terms and Obligations:**

This document places a number of responsibilities on each of the accepted student in the ENS Scholarship Program for Distinguished Students and his guardian, which the accepted student's guardian must abide by and abide by throughout his enrollment in the program, namely :

- 1) I fully realize that this is the grant does not include any fees and/or other additional services not specified by the program or the committees supervising it, and I have no right to claim the program to compensate me for any other amounts I paid that were not approved by the program and /or the program committees.
- 2) I hereby undertake the following:
  - a) Adhere to all the laws, policies and procedures adopted by the program and the committees supervising it.
  - b) Commitment to the school's laws and policies contained in the contract signed between me and the school administration "the parent/guardian's agreement," as this document and the contract are complementary to each other.
  - c) Commitment to the attendance and dismissal dates set by the school and maintain an attendance rate of at least 95% during the academic year, unless there is an official excuse, in which case I must submit the necessary reports to the school, as well as to the committees supervising the program (upon request).
  - d) Commitment to the dates of enrichment programs and active participation in them, and these programs are decided by the school administration according to the student's academic and social needs and include any programs that are held outside school hours as well.
  - e) The school administration has the right to take the necessary measures if the student does not comply with its policies, regulations, laws and/or instructions issued by it, including the expulsion of the student from the school, provided that he is notified by the program and/or the committees supervising it.
  - f) Supporting the student in improving his/her academic achievement as determined by the school at the beginning of the academic year, in addition to his/her periodic follow-up to achieve the academic level specified by the school, program and/or committees, if necessary. Appropriate intervention from the school in positive partnership with me.
  - g) Encourage the student to participate in school activities and events, which contribute to the development of aspects of academic achievement and social development of the student.

- h) Encouraging male/female students to join community and voluntary service programs, to work on their social and personal enrichment.
  - i) Continuous follow-up with the school administration, and commitment to any academic changes that may occur in the educational system and its requirements.
  - j) communication with the school administration about all the academic, social, or behavioral challenges facing the student, and cooperation with the school administration to find appropriate solutions, and submitting any complaint or observation to ENS.
- 3) Support the program as expected of me, and participate in forums, events, and activities that will improve the program and develop its standards in particular and the educational system in general.
  - 4) If you decide to withdraw the student from the program, or decides to transfer the student to another school that is not among the schools included in the program, I undertake the following:
    - a) Notify the program team officially before the start of the academic year.
    - b) Pay any financial obligations arising from this decision to the current school, according to the program's policy, and as stipulated in the parent's and school's contract.

**Article 2:**

**Violation of grant terms and obligations (violations):**

If I and/or the student do not comply with any of the conditions and obligations of the grant stipulated above, the program and/or the committees supervising it have the right to take any of the following actions, without being obligated to arrange them:

- 1) Notify me of the violation and/or breach if I resolve and/or settle this violation and/or breach within the period specified in the notification.
- 2) Referring the violation and/or the breach to the school for consideration and taking appropriate action.
- 3) Withdrawal and/or cancellation of the scholarship from the student, in whole or in part, if he/she does not achieve the academic level expected of him/her, bearing in mind that I do not have the right to re-register him/her in the scholarship again after withdrawing it.
- 4) Mandatory to refund the amount of the scholarship, including the tuition fees and/or any of the expenses that were paid by ENS for the specified academic year.

**Article 3:**

**General provisions:**

- 1) are complementary to each other, in addition to any changes that may occur in the draft document in the future.
- 2) By signing this document, I undertake to abide by all the items contained therein, and with any responsibilities or obligations required by the program later or specified in the policies and procedures manual of the program and/or the authority, which are notified to me.
- 3) This document is subject to local laws of the Emirate of the school's location and the relevant federal laws of the United Arab Emirates, and their provisions apply to the content of this document, unless there is any text to the contrary.
- 4) The Arabic text of this document is the text that prevails in all cases, regardless of any translation of this document for any purpose.
- 5) I have no right to assign to others any of my rights or duties, myself and the student, and set forth in this document.
- 6) The program expects the student to continue in the school chosen by his or her guardian during enrollment throughout his/her enrollment in the program.
- 7) If I submit a request to transfer the student to another school, the conditions of ENS are applied, and the following conditions are added to it:

- a) The guardian has the right to apply for a transfer only once during his enrollment in the program.
  - b) The new school must be within the same educational group, provided that the guardian bears the difference in the cost if it is higher.
  - c) The guardian submits the request with an explanation of the reasons, so that his request is studied.
- 8) If you decide the student's withdrawal from the program , or his/her transfer to another school that is not among the schools included in the program, the guardian must notify the program administration well in advance of the start of the semester, stating the reasons, so that the request is studied, and the program team is given an opportunity to search for solutions before deciding on the decision to withdraw, knowing that the parent/guardian bears any financial consequences arising from the decision to withdraw.
